REMARKS / NARRATIVE

OFFICER BURSON FOUND A STRUCTURE FIRE AT 264 3RD AVENUE WHILE ON PATROL, ENGINE 6 DISPATCHED (F.F HOLBEIN AND WALKER), WHILE PULLING UP TO THE SCENE HOLBEIN WAS GETTING THE TRUCK IN PUMP AND WALKER WAS GETTING THE LINES STRETCHED OUT, THEY WERE ADVISED BY SUBJECT THAT 2 CHILDREN WERE STILL IN THE HOUSE (FATHER) AFTER GETTING THEIR GEAR ON THEY PROCEEDED TO MAKE ENTRY THROUGH A REAR WINDOW TO DO A RESCUE, ONE FEMALE SUBJECT WAS REMOVED AND WAS TRANSPORTED TO U.S.A HOSPITAL THE OTHER WAS NOT FOUND BEFORE THE HOUSE WAS FULLY ENVOLED, F.F HOLBEIN WAS TRANSPORTED TO THE SPRINGHILL MEMORIAL HOSPITAL WHERE HE WAS TREATED FOR A BURN TO HIS R/HAND, THE HOUSE WAS EXTINGUISHED AND THE SECOND BODY WAS FOUND IN THE FRONT BEDROOM ON THE FLOOR IN CROUCHED POSITION. ALABAMA POWER COMPANY CALLED AND REMOVED THE POWER LINE, DFS CALLED FOR THE BODY, STATE FIRE MARSHALL CALLED FOR ASSISTANCE WITH THE FIRE INVESTIGATION, FAMILY MEMBERS STATED THAT THE FAMILY HAD BEEN HAVING TROUBLE WITH THE POWER GOING OUT WHEN YOU WOULD TURN THE FRONT PORCH LIGHT ON, FAMILY ALSO STATED THAT THERE WAS SOMEONE OUT YESTERDAY DOING REPAIRS, ALL THIS INFORMATION GIVEN TO THE FIRE MARSHALL AND THE DETECTIVES, FIRE HAD EXTENSIVE DAMAGE DUE TO THE AMOUNT OF FIRE BEFORE THE FIRE DEPT WAS NOTIFIED, THE HOUSE WAS BEING RENTED UNDER THE SECTION 8 PROGRAM THROUGH PRICHARD HOUSING AND WAS OWNED BY A T BONE INVESTMENTS LLC OUT OF DAPHNE ALABAMA, AFTER THE FIRE WAS EXTINGUISHED THE SCENE WAS TURNED OVER TO DETECTIVE THORNTON WITH THE CHICKASAW POLICE DEPT FOR INVESTIGATION WITH THE ASSISTANCE OF THE DEPARTMENT OF FORENSIC SCIENCE AND STATE FIRE MARSHALLS OFFICE. FAMILY MEMBERS ALSO STATED THAT THE HOUSE HAD ATLEAST ONE SMOKE DETECTOR IN THE KITCHEN AND THAT IT WORKED BECAUSE WHEN THE OCCUPPANT WOULD COOK SOMETIMES THE ALARM WOULD GO OFF.
